### Article 1 – Legal Provisions

### Article 2 – Access to the Website

## Article 4 – Website Management

For the proper management of the website, the administrator may at any time:

- Temporarily take the website offline to perform updates

## Article 5 – Responsibilities

## Article 6 – Collection of Data

Your data is collected by Maan Group B.V. Personal data is understood to mean: any information about an identified or identifiable natural person; an identifiable person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, identification number, location data, an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person.

The personal data collected on the website is primarily used by the administrator for maintaining relationships with you and, where applicable, for processing your orders.

## Article 7 – Your Rights Regarding Your Data

In accordance with Article 13(2)(b) of the GDPR, everyone has the right to access, rectify or erase their personal data or restrict the processing concerning them, as well as the right to object to the processing and the right to data portability.

You will receive a response to your request within 1 month of its submission. Depending on the complexity and number of requests, this period may be extended by 2 months if necessary.

## Article 8 – Processing of Personal Data

In the event of any violation of laws or regulations for which the visitor is suspected and for which authorities require personal data collected by the administrator, such data will be provided to them after an explicit and reasoned request by those authorities. These personal data will then no longer fall under the protection of the provisions of this privacy policy.

If certain information is necessary to access specific functionalities of the website, the controller will indicate the mandatory nature of this information at the time of data collection.
